PARCEL A:
 THE WEST 201 FEET OF THE SOUTHWEST QUARTER OF THE SOUTHWEST QUARTER OF SECTION 24, TOWNSHIP 23 NORTH, RANGE 5 EAST, WILLAMETTE MERIDIAN, IN KING COUNTY, WASHINGTON.

PARCEL B:
 BEGINNING AT THE NORTHWEST CORNER OF THE SOUTHWEST QUARTER OF THE SOUTHWEST QUARTER OF SECTION 24, TOWNSHIP 23 NORTH, RANGE 5 EAST, WILLAMETTE MERIDIAN, IN KING COUNTY, WASHINGTON; THENCE EAST ALONG THE NORTH LINE OF SAID SOUTHWEST QUARTER OF THE SOUTHWEST QUARTER OF SECTION 24, A DISTANCE OF 201 FEET; THENCE NORTH TO THE SOUTHERLY RIGHT OF WAY LINE OF COUNTY ROAD; THENCE NORTHWESTERLY ALONG THE SOUTHERLY RIGHT OF WAY LINE OF SAID COUNTY ROAD TO THE WEST LINE OF SAID SECTION 24; THENCE SOUTH ALONG THE WEST LINE THEREOF TO THE POINT OF BEGINNING.

 COMMENCING AT A POINT ON THE EAST BOUNDARY LINE OF SECTION 23, TOWNSHIP 23 NORTH, RANGE 5 EAST, WILLAMETTE MERIDIAN, IN KING COUNTY, WASHINGTON, WHICH POINT IS NORTH 0°12'43" EAST 1398.72 FEET FROM THE SOUTHEAST CORNER OF SAID SECTION 23 AND SOUTH 0°12'43" WEST 90.13 FEET FROM THE POINT OF INTERSECTION OF THE ABOVE DESCRIBED EAST BOUNDARY LINE OF SAID SECTION 23 AND THE CENTER LINE OF THE TRACT AND RIGHT OF WAY OF THE COLUMBIA AND PUGET SOUND RAILWAY; AND BEING THE TRUE POINT OF BEGINNING: THENCE SOUTH 0°12'43" WEST 420.63 FEET; THENCE NORTH 81°35'17" WEST 295.04 FEET; THENCE NORTH 0°12'43" EAST 400 FEET, MORE OR LESS, TO A LINE CONCENTRIC WITH AND 90 FEET (RADIAL MEASUREMENT) SOUTH-OF THE CENTER LINE OF THE COLUMBIA AND PUGET SOUND RAILWAY; THENCE EASTERLY ALONG SAID CONCENTRIC LINE 295 FEET, MORE OR LESS, TO THE POINT OF BEGINNING;

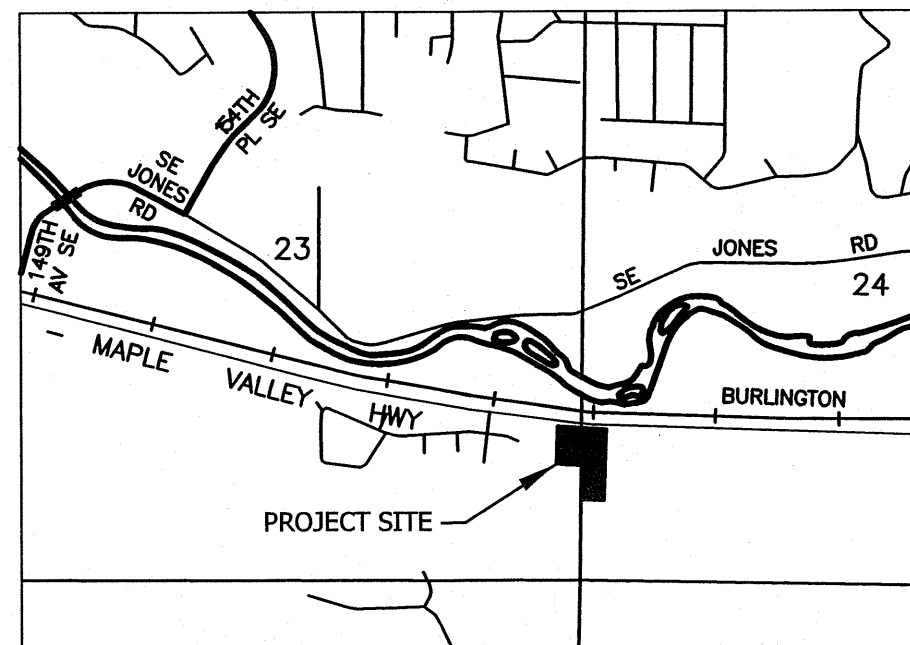

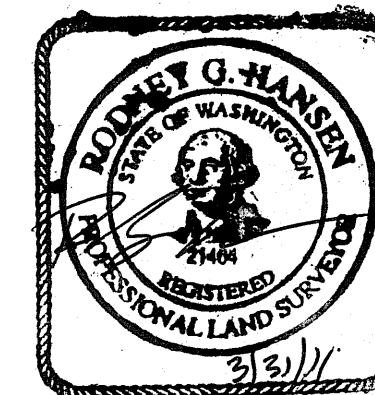
